PRESENTATION BY LILYFORD HOMES ON RETIREMENT HOMES IN BEPTON ROAD.

Mr. Maurice Ormorod gave a presentation on how the development is progressing.

The underground drainage and piling have been completed. With the groundwork completed the next stage is putting in the foundations for the building.

The company were aware that the closure of the footpath had caused some problems but felt that they had done their best to keep both the public and Budgens on good terms with them.

Mr. Ormorod took questions which were mainly on the landscaping of the area and the use of the underground water.

Cllr McAra thanked Mr. Ormorod and suggested that he might like to come back in six months time with a further update.

SDNP/19/03606/PRE - CONSIDER A PRE-PLANNING APPLICATION BY METIS HOMES AT WSCC/BRICKWORKS SITE IN BEPTON ROAD

Mr. Ally Kennedy, Community and Public Engagement was available to take questions on the preplanning application from Metis Homes.

Cllr McAra informed the committee that the Midhurst and Petworth Observer had requested a report for inclusion in the newspaper. As no reporter was present, he will be forwarding a report.

This site was the initiative between Midhurst Town Council, West Sussex County Council, Cowdray and the South Downs National Park.

Overall, the committee was in favour of the application, which showed best use of the natural features of the site and the provision of 50% affordable homes. However, it was disappointed in the lack of employment facilities on the site.

Mr. Kennedy confirmed that the company was taking consultee comments followed by a public consultation period of about 4-6 weeks. He expected that the full application would be submitted by the year end.
