P/42/19 – PLANNING APPLICATIONS

42.1 - SDNPA/19/03288/FUL

Retrospective change of use of public house ancillary storage area to car wash.

Half Moon Petersfield Road Midhurst GU29 9LL

Decision: Objection – The Town Council strongly objects to this retrospective application. The site for the proposed car wash sits at the entrance to the town and as such is an inappropriate development in this location. Signage, large advertising billboards will not be in keeping with the town's standards. Moreover, the South Downs National Park Authority's Local Plan states that it is imperative to preserve the environment and integrity of the towns and villages within the National Park.

The town council is also concerned about the increase in vehicles parking at the pub and entering and exiting on to a main road by a dangerous corner.

There is also the potential of flooding of toxic chemicals into the underground water table.

P/44/19 - PARKING ON PAVEMENT, PETERSFIELD ROAD (Cllr Upjohn)

The area along the Petersfield Road near the roundabout junction with Rumbolds Hill, vehicles continuously park up on the pavement causing an obstruction for pedestrians and damaging the paving slabs. Parked vehicles also block the sight line for children, the elderly and other adults exiting from St Margaret's Way.

It was proposed to discuss this matter with County Councillor O'Kelly to ascertain whether WSCC highways would consider erecting bollards on this side on the road as it has on the opposite side.
