P/52/19 - DECISIONS

P/53/19 - MATTERS OF REPORT

53.1 Cllr Coote explained that he had received concerns from local residence about the potential additional parking on Lambert's Lane following the move by Cowdray to Capron House. The SDNPA staff already park on Lambert's Lane. Jonathan Russell, Chief Executive for the Cowdray Estate, has informed Cllr McAra that staff will continue to park in Easebourne at the Cowdray offices and be transported to Capron House.

53.2 Cllr Morley raised concern about some of the signs entering Midhurst not being visible to traffic. Cllr McAra advised him to speak his County Councillor.
