Clerk had had a response from the CDC tree officer confirming that 'Trees sizes only required within a Conservation Area (TCA applications) like Midhurst and would include all trees (only cutting of live growth) with girths of 3 inches (75mm) in diameter at 1.5m (above ground level).

Clerk had not received a response to the Council's letter regarding poor documents for tree applications.

Cllr Coote informed the meeting that he and Cllr McAra had met Cowdray team dealing with the tree work on the land opposite the Alms Houses. Following the clearing and felling of some trees there will be a programme of tree planting.
