**109.1 SDNP/20/03271/CND** - 21 no. dwellings - Variation of Condition 19 of planning permission MI/04/04113/FUL - application to remove two groups of Western Red Cedar (Section A - group of six WRC's and Section B) one of group of nine WRC's) from approved Landscape scheme. Land adjacent to 78 Petersfield Road Midhurst West Sussex GU29 9JR

**Decision**: The Council STRONGLY OBJECTS to this application. It is detrimental to the landscape amenity of the site, contrary to the South Downs National Park's policy on tree retention and as agreed and documented in the original application the developers were instructed to design around the tress.
